Please read the following so that your boat can be launched without delays:

- In order to launch your boat in a timely manner, it may be necessary to replace your battery, add fuel, etc. **By initialing this form you are pre-authorizing charges up to \$200.00 for any needed items, i.e. battery, fuel, etc.** _____
- All ALA and DMV fee must be paid prior to launch.
- All unpaid Inland Boat Center balances must be paid prior to launch.

Inland Boat Center Valet Service Information/Rules and expectations

- **If you are storing with IBC for the 17-18 season, please give a week's warning prior to your first launch. This is to make sure your boat is ready for use.**
- **Summer Valet will end on 10/31/18; Please let one of our staff members know if it is your last time using your boat for the season. This is to insure that your boat is safe when the temperature drops below freezing.**
- All boat owners and authorized operators must have a current ALA boat operator's license while operating a boat.
- Boats in rack cannot exceed 4,000 lbs. Boats in rack cannot exceed 22 feet including swim step.
- **Please do NOT leave food in your boat. It will attract unwanted critters and they can damage your boat.**
- We will be open late for the firework celebration.
- Please call at least 1 hour prior to have your boat launched. If you would like to use your boat before 8 am, please call by 3pm the day before. Please allow for more notice on holidays.
- Please do not leave your boat in the ALA convenience dock. You may do so only if our dock is full.
- Please have an extra ignition key made and leave it with us.
- Due to space limitations at our dock, we may not be able to launch your boat until you arrive, especially on holiday weekends.
- Please use caution when leaving the docks. Do not hesitate to ask a staff members for help.
- Please lower your bimini top and tower when you are returning your boat for storage.
- Our insurance prohibits anyone from working on their boat on the premises.
- Please make sure we have your current contact information including daytime phone and email address on file.
- If you do not sign and complete the Winter Storage forms for 2018-19, you will forfeit your place in the racks for winter. If you do not intend on storing with IBC in the winter, please have your boat picked up within 10 days otherwise storage fees will be charged.
- **Customers that call to have their boat put in the water that do not show up will be charged with a fee of \$60, for putting the boat into the water and back into storage.**
- **If in the event the crane is down for maintenance or repairs, Inland Boat Center will not issue partial refunds or discounts.**
- **Please notify office staff, if you are through using or intend to return the next day, one way or the other. Please let staff know what time you intend on using it the next day.**

To have your boat launched, please call (909) 336-2300 between the hours of 8:00 am and 3:00 pm, 7 days a week (**Please do not leave a message**).

If any action arises out of the storage agreement, the prevailing party shall be entitled to any reasonable attorney's fees and costs. A party shall be deemed a prevailing party if the judgement is rendered in his/her favor or where the litigation is dismissed in his or her favor prior to or during trial, unless parties otherwise agree in the settlement or compromise.
